Using Risk Management Technology to Construct a Brownfields Inventory

Local Equity has partnered with environmental consulting firm Cameron-Cole and Envirosite, both ADEC Innovations, to bringing their extensive brownfield experience and proprietary property risk map (PRM) software to the City of Barstow, California, to develop a brownfield inventory and identify sites for further assessment.

In 2021, the California Department of Toxic Substances Control announced more than \$250 million in grants through its Equitable Community Revitalization Grant (ECRG) to encourage brownfield cleanup and redevelopment. In 2024 Barstow was approved for two community-wide assessment grants of \$350,000 each and Local Equity was selected as the project manager. To identify as many potential sites as possible in their limited amount of time, Barstow has partnered with Cameron-Cole to use Envirosite's PRM and their expert staff to develop a brownfields inventory and identify sites for further assessment through preparation of Phase I Environmental Site Assessments (ESAs), and, if/where needed, a Phase II as well. <u>Read more.</u>

Palm Springs airport gets OK for a multibillion-dollar upgrade

Palm Springs International Airport is launching a \$2.2 billion expansion, now that the Palm Springs City Council has approved a master plan for the project.

With its distinctive mid-century modern architecture and an airy, open design, the airport has been a city landmark since it opened in 1966. The master plan, approved Jan. 23, tries to preserve that character while adding new features and doubling the number of passengers per year.

"Our modernization efforts are about more than just improving infrastructure — it's about creating an experience that embodies the unique spirit and hospitality of Palm Springs while supporting the continued growth of our economy and tourism industry," Palm Springs Mayor Ron deHarte said.

The airport was built for about 1.5 million passengers per year, said airport spokesperson Jake Ingrassia. Passenger traffic jumped to 3.2 million in 2023 and 2024 and is expected to double to 6.4 million by 2042, as the region's population and tourism industry expand, he said. <u>Read more.</u>

11 years after a celebrated opening, massive solar plant faces a bleak future in the Mojave Desert

What was once the world's largest solar power plant of its type appears headed for closure just 11 years after opening, under pressure from cheaper green energy sources. Meanwhile, environmentalists continue to blame the Mojave Desert plant for killing thousands of birds and tortoises. The Ivanpah solar power plant formally opened in 2014 on roughly 5 square miles of federal land near the California-Nevada border. Though it was hailed at the time as a breakthrough moment for clean energy, its power has been struggling to compete with cheaper solar technologies. Pacific Gas & Electric said in a statement it had agreed with owners — including NRG Energy Inc. — to terminate its contracts with the Ivanpah plant. If approved by regulators, the deal would lead to closing two of the plant's three units starting in 2026. The contracts were expected to run through 2039. <u>Read</u> more.

Amazon announces 2,000 new job openings in the Inland Empire

Amazon officials have announced the availability of thousands of new full and part-time jobs in the Inland Empire. The jobs are at the company's newly opened inbound cross dock facilities in Fontana in San Bernardino County and Jurupa Valley in Riverside County, the company announced this month. According to the company, the new inbound cross docks are designed to receive and prepare goods for Amazon's fulfillment centers. Similar to distribution centers, the docks play a crucial role in quickly moving goods through Amazon's logistics network, enhancing efficiency in the supply chain. Amazon officials stated that job recruitment is part of the significant expansion in the Inland Empire, which underscores the company's commitment to growth and investment in the region. <u>Read more.</u>

Phoenix, Orange County and Inland Empire Emerge as Leading U.S. Industrial Markets

In the final quarter of 2024, industrial real estate remained one of the most stable segments within commercial real estate, according to CommercialCafe. Development pipelines slowed across most markets, while vacancies continued to rise at a controlled pace. As a result, the market trend in Q4 2024 focused on absorbing the record-breaking industrial developments of recent years. Key U.S. Industrial Market Insights:

- Overall Market: Phoenix maintained its position as the leading industrial real estate market, with Orange County and the Inland Empire in California rounding out the top three.
- Average Rent: All 30 major markets experienced annual increases in asking rents, with Orange County posting the highest nationwide average at \$16.2 per square foot.
- Vacancy Rates: Orange County was one of only five major markets to see a decline in vacancies quarter-over-quarter, achieving the lowest rate in the study at 4.2% in Q4.
- Industrial Construction: Across the 30 major markets, 34.5 million square feet of industrial space was delivered in Q4, with an additional 188.2 million square feet under construction. Phoenix led in both Q4 deliveries and active pipeline projects.
- Average Sale Price: The Bay Area remained the most expensive market for industrial space, with an average sale price of \$458.40 per square foot, followed by Orange County, Los Angeles, and the Inland Empire.
- Loan Maturities: Portland, Oregon, had the lowest share of industrial real estate loans maturing in 2025, followed by Bridgeport, Connecticut, and Baltimore.
- Search Trends: Houston recorded the highest online search volume for industrial real estate keywords in Q4, while Boston experienced the greatest year-over-year growth in search interest.

IE Bullet Train Gets Federal Praise As SF-LA Project Under Scrutiny

INLAND EMPIRE, CA - The flow of federal for a 400-mile high-speed rail project that would carry passengers between Los Angeles and San Francisco may come to a grinding halt as the Trump administration opened an investigation into the ongoing plan on Thursday.

While Republican leaders and the U.S. Transportation Secretary denounced that plan, publically calling it a spending disaster, another project slated to take passengers between the Inland Empire and Las Vegas received surprising praise.

In a federal news release, Sean Duffy, the U.S. transportation secretary, announced the federal review of the multi-billion dollar LA to SF project, calling it "massively over-budget and delayed." He also noted that the project has a lot of differences from the IE's project, managed by Brightline. <u>Read more.</u>


